You are invited to join our “**Ben Lash Trips**”, Boston Tour Trip, and Friday, June 20<sup>th</sup> through Monday, June 23<sup>rd</sup>, 2025

The trip begins with your flight from the Columbus John Glenn International Airport to the Boston Logan Airport. Transportation to and from Boston Logan Airport & the Boston Marriott Long Wharf hotel is included via the Boston subway system or private transportation. Ben Lash Trips reserves the right to fly from Columbus or Cleveland to stay within the trip budget.

Your trip includes 4 days & 3 nights' accommodations at the outstanding Boston Marriott Long Wharf Hotel. The Boston Marriott Long Wharf Hotel offers visitors fantastic views of the Boston Harbor with its waterfront setting. Guestrooms are fitted with modern amenities such as Marriott's signature flush bedding, coffee maker, refrigerator, and wireless Internet technology. Indoor pool, spa, sauna, health club provide indulgence and recreational options. Boston Marriott Long Wharf is close to Quincy Market, Faneuil Hall, New England Aquarium, the Whale Cruise departure, Old Town Trolley stop, overlooking scenic Boston Harbor, and is just minutes from Boston Common, the Old North Church, and the TD Garden.

The flight will leave the Columbus airport early Friday, June 20<sup>th</sup> & return late Monday, June 23<sup>rd</sup> to maximize your time in Boston. Members of the trip are responsible for transportation to and from the Columbus John Glenn International Airport.

The origin of the flight for the trip is from Columbus, Ohio. If you wish to travel from another location to join the trip or to use points to purchase your flight, I will reduce the cost of your trip by my flight allocation. Your trip will include a Whale watching cruise to Stellwagen Bank, the East Coast's most famous whale watching destination. Stellwagen's heavy concentration of humpback, finback, and minke whales guarantees an adventure filled with opportunities to view and learn about whales as they frolic in their natural habitat.

Your trip will include access to a day (with option for a second day) on the hop on, hop off Old Town Trolley. The Old Town Trolley makes a loop of the city with 18 stops to the sights of Boston. Each Old Town Trolley has a conductor to inform you of the sights of Boston. You will have the flexibility to visit the stops/sites that most interest you. The first stop for the Old Town Trolley is located at the hotel.

Your trip will include Friday & Sunday will be professionally guided walking tour of the Freedom trail (half of the Freedom Trail each day).

Your trip will include a Harbor Cruise (from the end of the Freedom Trail Tour to the hotel)
